With the upcoming changes to the Level of Care and the proposed algorithm, our focus has been, and will continue to be to work with DHSS to ensure our clients will continue to receive services under this new assessment tool. We will continue to work with the MO Alliance for Home Care and their Lobbyist this legislative session to restore cuts to the reimbursement rates.

DO YOU KNOW THAT....

- CMS has made revisions to the service definitions and regulations? The state is in the
 process of implementing the changes, revising regulations and MoADSA has been part
 of this process. We will continue to work with DHSS to ensure the proposed regulations, as we discussed, are filed.
- MoADSA has an open relationship with some of the top staff at the state departments that regulate and audit ADCs; such as Department of Health and Senior Services, Department of Social Services, Missouri Medicaid and Compliance Unit, and the Department of Mental Health. MoADSA continues to host staff from key State Agencies to present information and updates each year at our Annual Conference. It gives our members an opportunity to meet with them face to face and to discuss concerns and ask questions.
- As part of the HCBS Transition Plan required of the States by CMS proceeds to rollout, MoADSA continues to collaborate with the state agencies to ensure this transition is presented and understood by all. We offered a session on how to incorporate patient centered care in your ADC at the summer membership meeting this year. There is much to do so join with us to accomplish our goals.
